#### Instructions to Voters:

To Vote, fill in the oval next to your choice, example ( ● ).

To vote for a person whose name is not on the ballot, write the person's full name in the blank space and fill in the oval ( ● ).

If you make a mistake or want to change your vote do not erase, ask for a new ballot.

**WARNING:** If you receive an absentee or mail-in ballot and return your ballot by the deadline, you may not vote at your polling place on election day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on election day unless you surrender your absentee or mail-in ballot and envelope to the judge of elections to be voided to vote by regular ballot.

<b>BALLOT QUESTION</b> Shall the Pennsylvania Constitution be amended to change existing law and increase the power of the General Assembly to unilaterally terminate or extend a disaster emergency declaration—and the powers of Commonwealth agencies to address the disaster regardless of its severity pursuant to that declaration—through passing a concurrent resolution by simple majority, thereby removing the existing check and balance of presenting a resolution to the Governor for approval or disapproval?	<b>BALLOT QUESTION</b> Shall the Pennsylvania Constitution be amended to change existing law so that: a disaster emergency declaration will expire automatically after 21 days, regardless of the severity of the emergency, unless the General Assembly takes action to extend the disaster emergency; the Governor may not declare a new disaster emergency to respond to the dangers facing the Commonwealth unless the General Assembly passes a concurrent resolution; the General Assembly enacts new laws for disaster management?	<b>BALLOT QUESTION</b> Shall the Pennsylvania Constitution be amended by adding a new section providing that equality of rights under the law shall not be denied or abridged because of an individual's race or ethnicity?
